Chairman Walter called on others in attendance to introduce themselves. A copy of the registration sheet is attached to these minutes as Annex I.

The meeting was recorded to assist with compilation of the minutes.

READING OF THE MINUTES

Motion by Director Bischoff to dispense with a reading of the April 7 & 8, 2022, Board of Directors meeting minutes and approve them as distributed. Second by Second Vice Chairman Fenstad. Upon voice vote, motion carried.

OFFICER AND COMMITTEE REPORTS

Chairman - - Chairman Walter provided a summary of the June 9, 2022, Executive Committee meeting.

Executive Committee

Audit Report

Derek Flanagan, EideBailly, summarized the auditor's responsibilities, followed by the presentation and detailed review of the 2021 Garrison Diversion Audit Report. Reasonable assurance was obtained that Garrison Diversion's financial statements are free of material misstatements

Mr. Flanagan stated management's responsibility is to prepare the financial statements and EideBailly's responsibility is to express an opinion on the financial statements. Management is also responsible for developing and establishing internal controls relative to the audit. As part of the audit, EideBailly does obtain an understanding of the internal controls but does not offer an opinion.

Mr. Flanagan reported the audit opinion this year is an unmodified opinion on the modified cash basis of accounting, which is a clean audit. There is also a separate federal audit, which is done in conjunction with the financial statement audit over the federal programs listed. This audit testing is different because it surrounds compliance with the existing grants and agreements. An unmodified opinion was also expressed on compliance and internal control for the federal audit. This is the cleanest opinion the accounting firm can provide in a single audit. As a result, there were no federal findings to report.

Motion by Director Metzger to accept the 2021 Garrison Diversion Audit Report. Second by Director D. Anderson. Upon roll call vote, the following directors voted aye: D. Anderson, J. Anderson, R. Financial Statements

Merri Mooridian, Administrative Officer, Garrison Diversion, referred to and reviewed Garrison Diversion's financial statements for the period of January 1, 2022, through June 30, 2022. Copies of the financial statements are attached to these minutes as Annex II.

Revenues through June 30 are broken out as follows: General Fund \$4,049,007; MR&I Fund \$9,106,213; O&M Fund \$2,524,249; RRVWSP Fund \$9,968,794 and Irrigation Fund \$303,922.

Expenditures were: General Fund \$1,513,956; MR&I Fund \$9,096,475; O&M Fund \$2,138,433; RRVWSP Fund \$10,012,341 and Irrigation Fund \$121,693. Transfers in, which are indirect fees paid to the General Fund from the other funds, total \$396,889.

The income budget for 2022 is \$52,365,806. Income received through June 30 is \$25,952,185 or 49.6% of budget.

Total expenses budgeted for the year are \$51,920,006. After transfers in/out, the total is \$52,914,346. Total expenditures to date were \$23,279,787 or 44% of the budget.

Garrison Diversion's reserve accounts total \$7,413,125.

Deposits at Bank of North Dakota are \$10,274,792; First International Bank & Trust \$10,208,678; Farm Credit Services \$1,000 and Bremer Bank \$5,592,746.

Motion by Director Cayko to accept the financial statements for the period of January 1, 2022, through June 30, 2022. Second by Director Klosterman. Upon roll call vote, the following directors voted aye: D. Anderson, J. Anderson, R. Anderson, Bischoff, Blanchfield, Cayko, Cook, Fenstad, Hanretty, Johnson, Kassian, Klein, Klosterman, Koeser, Krivarchka, Marquart, Metzger, Ongstad, Orn, Pellman, Rogers, Walter, Vein and Zimbleman. 2023 Draft Budget

Cindy Hewitt, Accounting Specialist, Garrison Diversion, reviewed version three of the Draft 2023 Garrison Diversion Budget. Projected revenues are \$55,617,050 with expenditures expected of \$55,024,475. The final budget will be approved this fall.

Budget Timeline

Ms. Hewitt stated the Budget Timeline is used for the 2023 budget preparation process and is provided for the board's referral.

Vice Chairman - - Jay Anderson, Vice Chairman, commented on meetings and conferences he has attended on behalf of Garrison Diversion.

Second Vice Chairman - - Roger Fenstad, Second Vice Chairman, also reported on Garrison Diversion and Red River Valley Water Supply Project (RRVWSP) meetings he has partaken in covering a whole variety of issues.

Public Relations Committee - - Director Dave Anderson, Chairman, Public Relations Committee, reported the committee will meet on July 12 to discuss public relations activities. Kimberly Cook, Communications Director, Garrison Diversion, and Secretary for the Public Relations Committee, reported on recent press relating to the RRVWSP and upcoming public relations events.

Recreation Committee

Approved Projects

Director Klein, who chairs the Recreation Committee, informed the board the committee met on March 30 to review and consider the spring round of grant applications. A total of 22 grant applications were received from within 13 of Garrison Diversion's member counties for a wide variety of projects. There was \$700,000 available for the 2022 grant program of which \$434,731 was appropriated at the meeting.

Red River Valley Committee

Director Bischoff, Chairman, Red River Valley Committee, reported the committee met on May 20 by video conference to review a RRVWSP change order on Contract 5B, Transmission Pipeline East. The objective of the change proposal is to remove the fiber optic conduit from the project to minimize above grade appurtenances and other items that the landowners may damage between the installation for this project and the commission of the RRVWSP.

Director Bischoff also updated the board on the various activities and meetings he has attended regarding the RRVWSP.

Stump Lake Update

Duane DeKrey, Secretary, reported Garrison Diversion continues to wait for the 404 Permit to raise the road at the land owned by Garrison Diversion near Stump Lake. KLJ completed the environmental work and has been interfacing with the Corps of Engineers on this issue. The hope is still to begin construction this fall.

MR&I Committee

Water Supply Assistance Grant Program

Ms. Mooridian conveyed the MR&I Committee met May 18 to review and consider applications received for the Water Supply Assistance Grant Program. A total of 18 rural water grant applications were received and awarded. Total funding approved from the program at that time was \$47,039.

Ms. Mooridian also reported there is a balance of \$150,039 in outstanding project funds.

MR&I Construction Report

Mr. DeKrey referred to the MR&I construction report dated June 30. Total 2022 MR&I expenditures through June are \$45,581,307. Remaining approved federal MR&I funds are \$18,755,838. A copy of the report is attached to these minutes as Annex III.

Mr. DeKrey commented total reimbursements from April through June of 2022 are \$4,030,816. Projects receiving funds were the Northwest Area Water Supply (NAWS) Biota Water Treatment Plant, NAWS Souris Corner to Bottineau and the Northeast Regional Water District.

Five-Year Plan FY2022-2026 Update - - Ms. Mooridian referred to and explained the MR&I Five-Year Plan update received from the Department of Water Resources (DWR), stating this is similar to the five-year work plan, which was previously approved, except there has been an acceleration of the project schedule to four years within the five-year plan per request by the Bureau of Reclamation. The plan has a total projected project cost of \$186.4 million, of which \$117 million is for the NAWS Project and \$65 million is for the Eastern North Dakota Alternate Water Supply Project (ENDAWS). Copies of the letter received from the DWR regarding the acceleration, along with the funding table, are attached to these minutes as Annex IV.

NAWS FY2022

Ms. Mooridian referred to the letter received from the DWR requesting Garrison Diversion to allocate \$46.6 million of the estimated \$49 million of FY2022 MR&I funds to NAWS. A copy of the letter is attached to these minutes as Annex V. This funding is for construction of the Biota Water Treatment Facility Phase I near Max, design of the Biota Water Treatment Facility Phase III and for design and construction of the Minot Water Treatment Facility Phase III. This request has been presented to Garrison Diversion's MR&I Committee and Executive Committee, as well as the State Water Commission. All of which recommend approval by this board.

Motion by Director Marquart to approve \$46,600,000 in additional federal funding for the NAWS Project. This motion is contingent upon available funds, project must follow Federal MR&I Program requirements and delegates the State Water Commission secretary the ability to move funds between project elements to facilitate efficient project completion. Second by Director Blanchfield. Upon roll call vote, the following directors voted aye: D. Anderson, J. Anderson, R. Anderson, Bischoff, Blanchfield, Cayko, Cook, Fenstad, Hanretty, Johnson, Kassian, Klein, Klosterman, Koeser, Krivarchka, Marquart, Metzger, Ongstad, Orn, Pellman, Rogers, Tweed, Walter, Vein and Zimbleman. Those voting nay: none. Absent and not voting: Boote, Kaiser and Krueger. Motion carried.

ENDAWS FY2022

Ms. Mooridian next referred to the letter received from the DWR recommending Garrison Diversion approve allocating \$1,720,000 from the FY2022 MR&I funds to the ENDAWS Project in order to conduct additional engineering design and right-of-way acquisition. A copy of the letter is attached to these minutes as Annex VI.

Ms. Mooridian stated the MR&I Committee previously recommended approval of FY2022 funding for the ENDAWS 2022-2023 Work Plan, but that number increased a bit, making the official amount \$1,720,000.

This request has also been presented to Garrison Diversion's MR&I and Executive Committees, as well as the State Water Commission. All of which recommend approval by this board.

Motion by Second Vice Chairman Fenstad to approve \$1,720,000 in additional funding for the ENDAWS Project. Approval is contingent upon available funding and the project must follow Federal MR&I Program requirements and delegates the State Water Commission

Secretary the ability to move funds between project elements to facilitate efficient project completion. Second by Director Metzger. Upon roll call vote, the following directors voted aye: D. Anderson, J. Anderson, R. Anderson, Bischoff, Blanchfield, Cayko, Cook, Fenstad, Hanretty, Johnson, Kassian, Klein, Klosterman, Koeser, Krivarchka, Marquart, Metzger, Ongstad, Orn, Pellman, Rogers, Tweed, Walter, Vein and Zimbleman. Agriculture and Natural Resources Committee - - Director Cook, Chairman, Agriculture and Natural Resources Committee, announced the committee will meet on July 12 to receive an update on the building to be constructed at the Oakes Irrigation Research Site (OIRS). Dr. Mike Ostlie, Director, NDSU Research and Extension Center, will also provide an update on the plan for seeking funds for OIRS operations in the upcoming legislative session.

Kip Kovar, District Engineer, Garrison Diversion, and Secretary of the Agriculture and Natural Resources Committee, stated a preliminary meeting to discuss the plans for the proposed construction of the OIRS building was held with Craftwell earlier today. It is hoped the plans and specifications will be ready soon in order to go out for bids yet this fall with construction to follow as soon as possible.

RED RIVER VALLEY WATER SUPPLY PROJECT (RRVWSP)

Construction Report - - Mr. Kovar provided updates and shared photos of construction progress at the RRVWSP sites via PowerPoint. This included the Missouri River Intake Pumping Station and Wet Well Tunnel (Contract 2), Sheyenne River Outfall Discharge Structure and the Transmission Pipeline East (Contracts 5A and 5B).

RRVWSP Work Plan Update - - Mr. Kovar referred to the RRVWSP Work Plan Update of July 6, 2022, providing status reports on engineering design for pipeline segments 5C, 5D, 6 and 7. He also alerted the committee of upcoming change orders that will be presented to the (Lake Agassiz Water Authority (LAWA) Technical Advisory Committee (TAC) and Red River Valley Committee. A copy of the update is attached to these minutes as Annex VII.

ENDAWS Project - - Mr. Kovar reported KLJ is completing environmental surveys, and AE2S is performing field surveys. Once all the information is gathered, the ENDAWS alignment can be drawn, and right-of-way can be pursued.

2021-2023 Work Plan Funding

Mr. Kovar referred to the RRVWSP 2021 to 2023 Biennium Budget dated January 25, 2022, listing the work items and cost breakdowns of the \$89.7 million work plan budget. This is provided for the board's information.

Operational Planning

Mr. Kovar reported the LAWA TAC's Operational Planning Subcommittee met on June 28 and received updates on operation and maintenance cost estimates for the RRVWSP. Updates were also presented on the Project Participation Agreement's StateMod and Operation Framework exhibits.

Financial Update

Ms. Mooridian informed the board the Water Revenue Bond has been signed and drawn upon. She also refreshed the board on Series A, B and C of the interim agreements.

Program Schedule - - Ms. Mooridian referred to and reviewed the RRVWSP Program Schedule dated July 5, 2022, which shows the timeline of the ongoing RRVWSP construction projects.

Planning Level Budget - - Ms. Mooridian referred to the RRVWSP Planning Level Budget dated June 30, 2022. Of the \$139,033,167 total program budget, expenses are \$59,783,212 or 43% of budget. A copy of the budget is attached to these minutes as Annex VIII.

Project Participation Agreement - - Tami Norgard, Vogel Law, gave a brief background on the development of the Project Participation Agreement (PPA). At the end of May, work began on the exhibits followed by presentations of the exhibits, which are centered on the financing and operating of the RRVWSP. Another review is being done of the PPA draft. It should then be ready for distribution to the various user groups.

Ms. Norgard then provided highlights of the draft PPA.

User Outreach Meetings - - Ms. Mooridian commented on the negotiations and discussions with system users at the outreach meetings. A meeting was held recently with the City of Moorhead, who has expressed interest in re-joining the RRVWSP. Meetings have also taken place with the City of Washburn and McLean-Sheridan Rural Water.

DEPARTMENT OF WATER RESOURCES REPORT

Andrea Travnicek, Director, Department of Water Resources (DWR), addressed the board providing an update on the agency's current projects and activities, including administration and cost share policy updates, the Interim Drainage Committee, upcoming meetings and the water development plan.

CENTRAL ND WATER SUPPLY

Ms. Norgard reported on the appeal regarding the State of Missouri's lawsuit on the Central North Dakota Water Supply project, stating the lawsuit has been briefed as of the end of the month. To date, no oral argument date has been set. Hopefully, that will happen this fall.

ND WATER USERS/IRRIGATION ASSOCIATION REPORT

Dani Quissell, North Dakota Water Users/Irrigation Association, reported the Water Users has been focused on the DWRs' cost share policy changes and is putting together a comment letter with their feedback and incorporating comments from the basin meetings.

Ms. Quissell reported a hearing was recently held regarding the federal legislation the Irrigation Association has been working on to clarify the 28,000 undesignated acres in the Dakota Water Resources Act (DWRA) can be used to access project pumping power without having Reclamation develop those acres.

Ms. Quissell said if this legislation passes, anything that Garrison Diversion or other irrigation districts in the state would develop within the Missouri River corridor up to those 28,000 acres would qualify for project pumping power.

Ms. Quissell stated a hearing was held on the bill, along with several other state specific bills. The hope is to roll all these bills into one larger package that could pass both houses. This needs to happen by the year's end, or the process would have to start over.

IRRIGATION UPDATE

Ryan Anderson, Engineer, Garrison Diversion, referred to the map included in the meeting packet showing the current irrigation along the McClusky Canal. The blue pivots are the existing pivots in 2021. The yellow pivots are what will be added to the water service contract to be submitted to the Bureau of Reclamation for 2022. Roughly 240 acres will be added at Mile Marker 0. At Mile Marker 7.4, 135 acres are being added. Mile Marker 9 will add 115 acres, and there will be an expansion at Mile Marker 10 of 100 acres. This comes close to 700 added acres in 2022 for a total of approximately 8,000 irrigated acres. A copy of the map is attached to these minutes as Annex IX.

OPERATION & MAINTENANCE (O&M) UPDATE

Mr. Anderson reported the O&M staff finished sandblasting and recoating tunnel three at the Snake Creek Pumping Plant (SCPP). Since then, work has mainly been at the major slide repair project along the McClusky Canal, along with routine maintenance. Approximately 100,000 cubic yards of spoil have been hauled in 2022. A total of 2.39 million cubic yards have been hauled over the course of the project.

Mr. Anderson provided an update on the seven trenchless tunnels being installed within the slide repair project to elevate future slide issues. As of July 8, the final pipe was being installed, and a bulk of the construction crew was heading home. Only the cleanup work will remain. Garrison Diversion's O&M crew will begin its portion of the trenchless work next.

Mr. Anderson stated the next thing to prepare is a task order with Black and Veatch and AE2S to conduct Geotech work on a portion of the slides.

BUREAU OF RECLAMATION REPORT

Scott Hettinger, Deputy Area Manager, Bureau of Reclamation (Reclamation), referred to Reclamation's report dated July 11-13 and provided highlights from ongoing projects involving Garrison Diversion. A copy of the report is attached to these minutes as Annex X.

MR&I - - Mr. Hettinger reported Reclamation has been pushing the Administration to finalize the requirements for bill funding and the obligate the funds.

Mr. Hettinger also informed the board Camille Touton, Commissioner, Reclamation, will be visiting North Dakota on July 27. She will be making stops at the biota water treatment plant at Max, the SCPP and the RRVWSP intake at Washburn.

COST OF WATER

Mr. DeKrey reminded the board Reclamation had started at a cost of \$73,855 cubic feet per second (cfs) for water from the McClusky Canal. This is basically to repay the capital costs for building the canal. Recently, Reclamation's regional director and the area manager met with Garrison Diversion's management staff and officers in Carrington to present a revised number.

Mr. DeKrey remarked Reclamation subtracted the construction from 2000 on to reduce the cost, which was when the DWRA was implemented. Of the \$73,855 per cfs, Reclamation reduced the cost by \$26,354 per cfs for a revised cost of \$47,501 per cfs.

Mr. DeKrey said although this price is better than \$73,855, there is no recommendation being made to the board at this time. Garrison Diversion's staff is still reviewing the.

SNAKE CREEK EMBANKMENT

Mr. DeKrey reminded the board of the Snake Creek Embankment issue. Because of seepage concerns under the embankment that were identified as part of a study done by the Corps of Engineers (COE), the COE now limits the differential level between Lake Sakakawea and Lake Audubon to 43 feet. The consequence of that limitation to the McClusky Canal is the potential for Lake Audubon to be lowered during extreme drought events, preventing the necessary flow being supplied to the canal.

Mr. DeKrey has asked the COE to fix the problem, and they came up with various options, but the proper way was approximately \$200 million. The COE ended up indicating it would never be fixed because the Dam Safety Program overrides anything else, and should the Snake Creek embankment fail, the water would enter Lake Sakakawea without being noticed. Plus, there would be no loss of life or property.

Senator Kramer went to bat for Garrison Diversion. In one of the Water Resource Development Act (WRDA) bills, language is included stating the economic impact of an embankment failure at Snake Creek must be considered. There is a large power line, a railroad line, communication lines, irrigated land and the highway all going through that area. It is believed it would cost billions of dollars if the embankment were to fail.

Mr. DeKrey stated the COE is preparing a Dam Safety Modification Study and National Environmental Policy Act (NEPA) review and plans to share the preferred alternative later this summer. Reclamation and Garrison Diversion continue to prepare a feasibility design and cost estimate to provide water to SCPP and the McClusky Canal in times when the Audubon Reservoir restriction is implemented.

SOUTHWEST WATER AUTHORITY

Jen Murray, Manager, Southwest Water Authority, presented their 2021 annual report and provided a status report on Southwest Pipeline projects, which first began construction 35 years ago and continues to grow.

TRIP REPORTS

Chairman Walter referred to the written trip reports included in the meeting packets from directors who attended the National Water Resources Association's Federal Water Conference and the Groundwater Management Association Conference.

Vice Chairman Anderson provided comments on the topics covered at the Groundwater Management Association Conference he attended in Colorado.

GENERAL MANAGER'S REPORT

AVI - - Mr. DeKrey provided an update on the audio/visio project, stating partial installation is taking place in the board room this week at the headquarters' office in Carrington. There are still a couple pieces of equipment that have not arrived causing further delays in project completion.

UPCOMING EVENTS

Chairman Walter reviewed a list of upcoming water-related meetings and events.

The attached Garrison Diversion Unit State Municipal, Rural, and Industrial Water Supply (MR&I) Program Five-Year Plan for fiscal years 2022 to 2026 is used to address project funding, variations in federal appropriations, and is submitted to the Bureau of Reclamation for their use in estimating the State's capacity to expend funding. Please note, at the request of the Bureau of Reclamation, the project cost schedules have been accelerated to four years within the five-year plan.

The Northwest Area Water Supply (NAWS) Project is projected to receive the majority of the MR&I Program funding in the Five-Year Plan, involving the Biota Water Treatment Plant Phase I, Biota Water Treatment Plant Phase II, and Minot Water Treatment Plant Phase III (see attached map). The Department of Water Resources and Water Commission members will continue to work with the Garrison Diversion Conservancy District regarding MR&I Program allocations from the federal government to address funding for the Eastern North Dakota Alternative Water Supply Project, as outlined in the Five-Year Plan.

The attached plan has a projected total cost of \$186.4 million with estimates for each year of the plan. The federal obligation would be \$155.7 million, based on 100 percent federal funding on the Biota Water Treatment Plant, 65 percent federal on the Minot Water Treatment Plant, and 75 percent federal on the Eastern North Dakota Alternative Water Supply Project.

The Bureau reviewed MR&I funding through FY2021 and determined the MR&I federal authorization balance is \$76 million. This leaves a future federal obligation of \$79.7 million over the Five-Year Plan. Federal funds are indexed each year to allow for ordinary fluctuations of construction costs incurred after the date of enactment of the Dakota Water Resources Act of 2000. The actual federal funding is dependent on annual Congressional appropriations.

This request was presented to the State Water Commission at their May 12, 2022 pre-commission meeting, with consideration for final approval at their June 7, 2022 meeting.

This request is to allocate \$46.6 million of the estimated \$49 million of FY2022 federal Municipal, Rural, and Industrial Water Supply (MR&I) Program funding to the Northwest Area Water Supply (NAWS) Project. The remaining appropriation of \$2.4 million would be \$0.68 million for state MR&I program administration and \$1.72 million for continuing work on the Eastern North Dakota Alternative Water Supply Project. A State Municipal, Rural, and Industrial Water Supply Program FY2022 Federal Funding Summary is attached.

The Biota Water Treatment Facility was determined to be 100 percent federal funding responsibility. The FY2022 funds of \$27.7 million are sufficient to cover the remaining federal balance for construction of the Biota Water Treatment Facility Phase I (Contract 7-2A/4-1A) near the City of Max with a completion date of June 30, 2024. There is another \$2.4 million for design of the Biota Water Treatment Facility Phase II (Contract 7-2B).

There is funding for design and construction of the Minot Water Treatment Facility Phase III (Contract 7-1C). The total estimated cost is \$25.2 million, with project funding split between a 65% federal share of \$16.4 million, and a 35% local share of \$8.8 million, being paid by Minot.

This request was presented to the State Water Commission at their May 12, 2022 pre-commission meeting, with consideration for final approval at their June 7, 2022 meeting.

I recommend the Garrison Diversion Conservancy District approve the Northwest Area Water Supply Project for additional federal funding of \$46,600,000. This approval is contingent on available funding, that the project follows Federal MR&I program requirements, and delegates to the Secretary the ability to move funds between project elements to facilitate efficient project completion.

Garrison Diversion Conservancy District (District) is requesting \$1,720,000 from FY2022 Federal Municipal, Rural, and Industrial Water Supply (MR&I) Program funding to conduct additional engineering design and right of way acquisition on the Eastern North Dakota Alternative Water Supply (ENDAWS) Project. The overall MR&I FY2022 budget is \$49,000,000, with \$46,600,000 being recommended for the Northwest Area Water Supply Project.

In January 2019, the District requested the Bureau of Reclamation (Bureau) to consider ENDAWS and evaluate up to 165 cubic feet per second of water from the McClusky Canal to serve as an alternate water supply for the Red River Valley Water Supply Project. In September 2019, the Bureau began the Environmental Impact Statement (EIS) process for ENDAWS. The Bureau completed an EIS in November 2020, and a record of decision was signed January 15, 2021.

Attached are tables with a MR&I funding summary, schedule, and an ENDAWS MR&I funding summary. This request was presented to the State Water Commission at their May 12, 2022 pre-Commission meeting, with consideration for final approval at their June 7, 2022 meeting.

I recommend the Garrison Diversion Conservancy District approve additional funding of \$1,720,000 at 75 percent, resulting in total Federal MR&I Program funds of \$3,600,000, with \$1,230,000 funded at 100%, and \$2,370,000 funded at 75%, to the Garrison Diversion Conservancy District for the Eastern North Dakota Alternate Water Supply Project. This approval is contingent on available funding, that the project following Federal MR&I Program requirements, and delegates to the Secretary the ability to move funds between project elements to facilitate efficient project completion.

CONSTRUCTION

Wet Well Construction Contract 1

The last finish grade pour (approximately 1.5' thick) completed on August 30 was deemed defective. The final floor heaved due to poor water pressure, and two secants continue to leak small amounts of water. We are currently working with the contractors to remedy the issues. Grout void space below the existing 1' reinforced concrete slab and secant repair will be removed from this contract and added to Contract 2 through Work Change Directive No.1. This will allow Contract 2 to continue without delay in schedule.

Pipeline Construction

Contract 5A

All pipe and trenchless work have been installed to date (5,950' total distance). The pipeline walk through was completed and approved. Fifty percent of the final restoration has been completed. Final restoration is delayed due to the wet conditions.

To date, \$7,697,689.95 has been paid on the original contract amount of \$8,366,201.00.





Contract 5B

Soils training was held on May 26 with contractor, subcontractors, owner and consultants. Contractor delivered construction management office trailer. Topsoil has been removed from the first mile in preparation for the July 11 pipe delivery. The original pipe delivery of June 15 was delayed due to surface blemish in the steel coil. After further analysis, there are no structural concerns with the 1 mm blemish (see reports for further information).

Discharge Structure Construction

The contractor has reached substantial completion and is installing railing and grates this week. To date, \$1,476,884.00 has been paid on the original contract amount of \$1,516,955.00.

Heavy rainfall created some erosion, which will need repair.







Missouri River Intake Tunnel and Screen Final Design Contract 2

As the apparent low bidder at \$18,896,900, Michels was issued notice of award on June 9, 2021. Michels has completed the road work, temporary bridge and coffer dam. The seal plug was poured. All pipe has been delivered, including the micro tunneling boring machine. It is anticipated tunneling will begin early July 2022. To date, \$8,418,260.93 has been paid on the original contract amount of \$18,896,000.00.

Three claims have been submitted by the contractor 1) differing site conditions on the coffer dam, 2) differing site conditions for the tunnel and 3) delays due to permit 33 requirements. We are working to resolve the issues.





DESIGN

Pipeline segments 5C (8 miles), 5D (10 miles) and 6 (25 miles) are currently under design. Plans and specifications have been submitted for review.

State Municipal Rural and Industrial Program

Northwest Area Water Supply (NAWS)

Construction activities are nearing completion for Contract 7-1B (Minot Water Treatment Plant Improvements) and construction is substantially complete on the distribution pipeline Contract 2-4C. Construction is ongoing for the Lansford Reservoir and Pump Station (Contract 4-3A/5-3A) and Contract 7-2A Biota Water Treatment Plant. Construction has begun on the South Prairie Reservoir and Hydraulic Control Structure (Contract 5-1A/B).

Design efforts of the Snake Creek Intake Modifications (Contract 6-1A) are ongoing. The 95% plans were provided for Reclamation review and Reclamation responded with comments. Consultants are working to finalize to 100 percent. The project is two phases based on U. S. Army Corps of Engineers 408 permitting requirements. One phase will include the work that requires a Corps permit and the other phase will include the tasks that do not require a permit. Reclamation is awaiting the updated plans for review. Reclamation and the North Dakota Department of Water Resources are working on a Facility Use Agreement which will allow the NAWS project to use this facility. A meeting was held in March to discuss the proposed Facility Use Agreement with the State reviewing the latest draft.

Design work is ongoing for the Bottineau Booster Pump Station and Reservoir (Contract 5-4A/B). Reclamation has reviewed the 90% design Plans and Specs and provided comments.

Reclamation hosted a virtual meeting of the NAWS Adaptive Management Team in March to discuss comments received on the draft Adaptive Management Plan. Reclamation is considering the comments received and will provide responses to comments/revised plan which will be shared with the team members. A meeting will be scheduled yet this summer.

Reclamation is also drafting an Operations & Maintenance agreement for the NAWS Biota Water Treatment Plant. At a recent meeting of the Water Commission, the Commission approved a motion that the Department of Water Resources and the City of Minot will be parties to this cooperative agreement. The goal is to have an agreement in place prior to the start-up of the Biota Water Treatment Plant.

Eastern North Dakota Alternate Water Supply

Reclamation has met with Garrison staff and consultants to discuss next steps in moving this project forward with project design to ensure compliance with National Environmental Policy Act (NEPA) commitments. Additional coordination will continue as needed throughout this fiscal year.

Southwest Pipeline Project

Contract 1-2A, Supplementary Raw Water Intake – The marine and pipe contractors are onsite. The marine contractor is working to install piles and should be completed in early July. The pipe contractor is working at Beulah Bay to prepare the pipe for installation. Another contractor is mobilizing to the work site and is expected to start drilling activities around July 9. A biologist is onsite monitoring for Piping Plovers, which is one of the environmental commitments. Reclamation participates in bi-weekly coordination calls on this project with the sponsor, U.S. Army Corps of Engineers, and others.

Construction is substantially complete on the Dodge and Richardton Pump Stations (Contracts 4-1E & 4-2B).

Cooperative Agreement

Reclamation and Garrison Diversion's working relationship for the State Municipal, Rural, and Industrial (MR&I) Program is defined by the terms of a Cooperative Agreement (R17AC00049). Fourteen modifications have been completed for this agreement for the purposes of adding construction projects, engineering projects, and/or obligating funds to the agreement.

The period of performance of the agreement is to September 30, 2022. Dakotas Area Office has learned that the existing cooperative agreement can be extended rather than entering into a new cooperative agreement. Reclamation is working with Garrison and the Department of Water Resources staff to identify State MR&I activities and administrative costs planned for FY2022 thru FY2026 and other documentation needed to modify this agreement to include additional administrative costs, construction projects and obligate FY22 funding (appropriations and BIL funding).

Indian MR&I Program

Standing Rock MR&I System

The Tribe has awarded the Standing Rock Water Treatment Plant Membrane Equipment Procurement project to WesTech Engineering, Inc., from Salt Lake City, Utah, in the amount of \$1,033,556.51. These ceramic membranes will be used to increase the water treatment capacity of the Standing Rock Water Treatment Plant from 3 MGD to 5 MGD. Bartlett & West is the engineer for this project. Change Order No. 1 has been processed, upgrading clean in place (CIP) and backwash pumps and increased the contract by \$117,391.78 for a total contract price of \$1,150,948.29. Bartlett & West has designed and prepared plans and specifications for the installation of the procured membranes. The installation contract was bid on February 11, 2021, with no bidders. The Installation contract was readvertised with a bid opening of March 16, 2021. The Installation Contract received three bids with the low bid coming from American General Contractors, Inc. of Valley City, North Dakota in the amount of \$2,021,350.87. Notice to Proceed was issued on August 5, 2021. The Substantial Completion Date is March 31, 2022. Due to several of the construction supplies having long lead times, the Substantial Completion date will not be met. The ceramic membranes were delivered to the Standing Rock Water Treatment Plant on November 16, 2021.

The demolition of the Fort Yates Water Treatment Plant and intake was advertised on October 29, 2021, with a bid opening held on November 30, 2021. There was one bid received in the amount of \$2,961,634.91 from Wagner Construction. This bid is \$1,471,928.36 below the Technical Service Center engineer's estimate of \$4,433,563.27. Wagner construction is currently in the process of submitting the submittals required by the contract specifications. The work includes the demolition of the Water Treatment Plant and associated features, the demolition of the intake site, and the reclamation of the lagoons and ponds. These features have been decommissioned from the Standing Rock Rural Water System and no longer serve a purpose. The Technical Service Center completed the 100% plans and specifications, and Bartlett & West will be administering the contract. The award of the Fort Yates Demolition project to Wagner Construction was approved at the February Tribal Council meeting and contract documents have been executed. A pre-construction conference was held on March 30, 2022. This project is currently in the submittal review stage and it is anticipated that construction will start in August or September 2022.

I.H.S. held a bid opening for Phase II of the Fort Yates Main Replacement project on April 20, 2021. Two bids were received with the low bid being received from Elite Construction in the amount of \$887,960. Contract SR2021-CW-1 is generally described as follows: construction of approximately 4,700 feet of 6-inch and 4-inch PVC pipe and 960 feet of 2-inch and 1-inch high density polyethylene (HDPE) service lines in the community of Fort Yates, North Dakota. The current pipe system consisting of 8, 6, and 4-inch water main pipe will be abandoned in place. The project also includes installation of gate valves, fire hydrants, corporation stops, curb stops, concrete driveway and sidewalk replacement, asphalt restoration, and curb and gutter replacement. The notice to proceed was issued on July 14, 2021, with construction beginning on July 19, 2021. The final completion date will be approximately November 1, 2022. Elite Construction has started up construction and are on track to be finished prior to the final completion date.

Spirit Lake MR&I System

Preliminary design and right-of-way acquisitions continued on several projects including: Fort Totten Community Upgrades, Tokio Service Area, Service to Warwick School, and Warwick Service Area.

Fort Totten Community Upgrades' design has been completed by I.H.S. Easements have been signed and awaiting the Grant of Right of Way from Bureau of Indian Affairs (BIA). The Hazardous Materials survey was completed by Bureau of Reclamation in June and the Archaeology Review was completed in July.

Reclamation staff has continued to work with the Tribe's operators to help resolve operation and maintenance issues with the B6 Booster Station, the St. Michael control vault, and the Water Treatment Plant.

Fort Berthold Rural Water System (FBRWS)

Reclamation paused work on the categorical exclusion checklist (CEC) for constructing a road to the South Mandaree Intake site due to not having a consultants environmental and cultural report to work from. Work will resume on the CECs after a class III survey-inventory is conducted. The Tribe has asked Reclamation to get U.S. Army Corps of Engineers permits for new raw water intakes sites in the South Segment (Twin Buttes area) and North Segment (Little Shell area). The Corps requires a SF-299 to be submitted for the proposed projects; Reclamation has started work on the SF-299.

Right-of-Way meetings are periodically held with Bureau of Indian Affairs (BIA) regarding the lack of recorded FBRWS easements in BIA's TAAMS database. BIA has recorded as legal documents 13 Superintendent-signed grant of easement documents. BIA's surveyors are preparing maps of definite location, and associated narratives, for areas that previously had Superintendent-signed but unrecorded easements.

The 2022 System Improvement-Subsequent User contract was awarded to Storms Construction. Coordination continues with Indian Health Service (IHS) to get Tribal members connected, where possible, to further the Tribes' remaining construction ceiling dollars. FBRW obtained IHS concurrence to have the IHS mega-contractor install connections for non-tribal members, pasture taps, and line extensions, knowing that FBRW would use Reclamation-provided construction funds to cover those costs.

Turtle Mountain Rural Water System

Contract 3-2 Membrane Treatment Improvements - The membrane treatment project will address the formation of disinfection by-products caused by an organic component in the source ground water. Project re-advertised in September 2019, with two responsible bidders submitting bids, with apparent low bidder being approximately \$1 million over. Consultant negotiated with low bidder, and project was awarded in July 2020. Construction began fall 2020 with the project completion scheduled in 2022.

Contract 2-4 Thorne Reservoir and Booster Station – This project includes the construction of a 500,000-gallon raw water reservoir and booster pumping station, which will help to meet

pressure and quantity demands on the system and will increase the efficiencies of the well field pumps. This project was advertised spring 2020, with all bids being \$3 million plus above engineer's estimate. Consultant amended the Plans & Specs, and re-advertised fall 2020. Negotiations with contractor took place with the project being awarded spring 2021. Construction has begun with the foundation and walls of pump station being completed. Interior work continued through the winter with excavation of reservoir currently taking place with substantial completion scheduled or fall.

Contract 1-10 Highway 43 Corridor Phase 3 – This project continues to add main line and service connections along Highway 43 west of the Lake Upsilon area (Phase 2). This project will complete a loop in the system to ensure reliable service to the community. Design is complete. Turtle Mountain worked with Rollet County as a project sponsor to secure North Dakota state grant funding.

Contract AB-17-J18 Reservoir A Replacement – Will replace two existing water tanks with a one-million-gallon composite water storage tank. Bids were opened September 9, 2020. All bids were \$2 million over engineer estimate, so contract was not awarded. Negotiations with the Contractor took place and project was awarded spring 2021. Construction is nearing substantial completion with coating currently being performed.

Contract 4-2 Belcourt Sewer and Water phase 4 – This project will replace aging existing water and sewer lines within Belcourt. It does not have any Bureau of Reclamation funding. It was awarded and began construction in May 2022.

Contract GP-20-J85 San Haven Water Main Replacement – Replacement of water main in the vicinity of San Haven. Plans and Specs were delivered to Reclamation for review, and comments were provided. The project is scheduled for advertisement July 2022.

Trenton Indian Service Area

The Hilltop Water and Sewer Replacement and Pressure Reducing Valve (PRV) Vault project was awarded to Teraflex Group, LLC for \$495,835 and construction work was started summer 2018. The project installed 2539 LF of water line and will replace the existing Booster Station B with a PRV to connect to the existing Western Area Water Supply mainline. User agreement with Western Area Water Supply is still being negotiated, with work on the PRV to be completed when agreement is finalized.

Principal Supply Works

Repayment Contract

Reclamation continues to collaborate with Garrison Diversion on the pricing of the capital repayment of the Garrison Diversion Unit Project. On June 29, Regional Director presented Garrison Diversion with a repayment cost of \$47,501 per cubic feet per second. Reclamation continues to work with Garrison Diversion on an amendment to include the 145 cubic feet per second for Eastern ND Alternate Water Supply (ENDAWS) and the reformulated irrigation components into a repayment contract.

Snake Creek Pumping Plant (SCPP)

Reclamation continues discussion with the Corps of Engineers on the Snake Creek embankment foundation concerns. Reclamation has signed to be a cooperating agency with the Corps of Engineers in preparing their Dam Safety Modification Study and National Environmental Policy Act (NEPA) review. The Corps plans to visit SCPP in late July to share the preferred alternative for the EA. Reclamation and Garrison Diversion continue to prepare a feasibility design and cost estimate to provide water to Snake Creek Pumping Plant and the McClusky Canal in times when the Audubon Reservoir restriction is implemented.

McClusky and New Rockford Canals

Reclamation and Garrison Diversion staff conducted the semi-annual site visit of the McClusky Canal slide repair on June 30, 2022. Reclamation is working on extending the McClusky Canal slide repair cooperative agreement, R17AC00161, to December 31, 2024. This agreement is currently scheduled to expire on September 30, 2022.

Irrigation

Jamestown Dam

Significant rainfall events in the past months have filled Jamestown Dam's joint-use pool and is currently 25% full (48,000 acre-feet) into the flood control pool. Combined releases with Pipestem Dam are 1,400 cubic feet per second. Dickey-Sargent Irrigation District's 4,000 acre-feet of storage has been considered refilled. Reclamation awarded Contract No. 140R6021C0013, Jamestown Dam Stilling Basin Concrete Floor Repairs, to Engineering & Construction Innovations, Inc. out of Minnesota in the amount of \$765,450. This work would start in September 2022.

Turtle Lake and McClusky Canal Irrigation Areas

The total acres irrigated from the McClusky Canal is 7,312 acres. Reclamation resent water service contract amendment #10, to increase the 2022 irrigated acres by 360 acres to a total of 7,672. Reclamation completed National Environmental Policy Act (NEPA) and cultural resource reviews on Garrison Diversion's MM7.4R, 9.0R and 9.5L proposed irrigations projects.

Standing Rock Irrigation Project

The Tribe has been approved to use construction funds to replace the buried power lines at the Fort Yates Unit and inspection and rehabilitation of the cathodic protection of Eagle Unit pipeline. Higher than expected bids kept the Tribe from awarding the contract. The Tribe is working to get the powerline rebid after making a number of changes to their specifications based on discussions with numerous prospective bidders. Reclamation is also working with the Tribe to schedule a Closed Circuit Television (CCTV) or Light Detection inspection of the Eagle Unit pipe. This inspection with the Tribe and their irrigator is to develop a long-term plan that addresses the future of their three irrigation units. This plan will then be used to explore the availability of funds to complete their efforts.

Recreation Development

A new 3-year contract is currently underway for the McLean County Sheriff's Department for the 2022 season. Bureau of Reclamation and Bureau of Land Management (BLM) has a Law Enforcement Officer on site during the 4th of July and Labor Day.

Traffic counters were installed the week of May 23 and will be removed after Labor Day weekend. No camp host has been hired to date for the 2022 recreation season. A press release stating no fireworks was released prior to the 4th of July. Garrison Diversion Conservancy District relocated four concrete picnic tables from North Dakota Game and Fish (NDGF) lands to the Chain of Lakes. They also picked up four shelters to be placed at Chain of Lakes this summer, locations to be determined (TBD). Reclamation and the Garrison Diversion are planning to purchase a storage shed for East Park Lake this summer.

North Dakota Natural Resources Trust

Modification for FY22 agreement in process. The trust is getting 2,546,000 for FY 22.

Wildlife Program

Lonetree

FY22 funding for Fish and Wildlife Service and North Dakota Game and Fish is being completed and dispersed soon. The FY22 National Environmental Policy Act (NEPA) Workplan has been completed and signed. A new 5-year agreement is being drafted a year early for Lonetree. This will adjust the agreement to fall in line with the yearly budget for Lonetree.

Audubon

Memorandum of Agreement (MOA) is currently under review by Garrison Diversion Conservancy District, dirt tour is scheduled for Lonetree Wildlife Management Area (WMA).

Arrowwood

The electric fish barrier was started on March 23, 2022. Water was flowing over the spillway section of the fish barrier road. The fish barrier road and the bypass channel road surfaces will likely need repairs this fall as a result of Jamestown Reservoir's flood control operations.

Scattered Tracts

Semi-annual meeting was conducted over Microsoft Teams on March 8, 2022. A meeting was conducted between Reclamation and Garrison Diversion discussing the 1986 U.S. Fish and Wildlife Service Memorandum of Agreement (MOA) modification to reduce payments to U.S. Fish and Wildlife Service. Reclamation received Garrison Diversion comments on the MOA on 6/27.
