### Garrison Diversion Conservancy District Carrington, North Dakota

### August 19, 2024

A meeting of the Garrison Diversion Conservancy District Municipal, Rural & Industrial (MR&I) Committee was held on August 19, 2024. The meeting was called to order by Chairperson Kaiser at 1:00 p.m.

### MEMBERS PRESENT

Board Chairman Alan Walter Committee Chairperson Geneva Kaiser Director Kyle Blanchfield (by video conference) Director Nikki Boote Director Steve Metzger Director Kenny Rogers Secretary Merri Mooridian

### OTHERS PRESENT

A copy of the registration sheet is attached to the minutes as Annex I.

The meeting was recorded to assist with compilation of the minutes.

### READING OF THE MINUTES

Motion by Director Boote to dispense with the reading and approve the May 14, 2024, MR&I Committee minutes. Second by Director Rogers. Upon voice vote, motion carried.

### RETURN OF GRANT FUNDS

**Southeast Water Users District - -** Geneva Kaiser, Chairperson, reported in August of 2022, Andy Wolters was awarded funding from the Water Supply Assistance Grant Program (WSAGP) in the amount of \$8,475. The pipeline route had to be changed causing the project to become too expensive. Instead of hooking up to rural water he ended up drilling a well; therefore, these funds can be returned to the reserve fund.

### REQUEST FOR EXTENSION

### North Prairie Regional Water District

Three WSAGP grant recipients from the North Prairie Regional Water District (NPRWD) are approaching the two-year project deadline. After contacting the NPRWD's general manager

on the status of these projects, a request was received for an extension on projects for Joann & DuWayne Hendrickson, Dean Keller and Michael & Crystal Wing, indicating the projects will be complete by fall of this year.

Motion by Director Metzger to extend the project deadline for Joann & DuWayne Hendrickson, Dean Keller and Michael & Crystal Wing from the North Prairie Regional Water District until May 31, 2025. Second by Director Rogers. Upon roll call vote, the following directors voted aye: Blanchfield, Boote, Kaiser, Metzger, Rogers and Walter. Motion carried.

### CURRENT FUNDING TABLE & PROJECT REVIEW

Merri Mooridian, Secretary, referred to the WSAGP outstanding projects table, reporting the program began in June of 2021, and the total of outstanding projects is \$147,213. Funding approved in 2024 is \$128,037. Expenditures for 2024 total \$46,345. A copy of the table is attached to these minutes as Annex II.

### COMPLETED PROJECTS

Ms. Mooridian referred to the WSAGP completed projects table through 2023, stating the total amount of approved projects is \$470,746 with an expended amount of \$358,401. Projects that did not come to fruition total \$112,344, which goes back into the WSAGP reserve account. A copy of the table is attached to these minutes as Annex III.

### **REVIEW OF WATER SUPPLY ASSISTANCE GRANT APPLICATIONS**

### **Rural Water Requests**

### Cass Rural Water District

Jason Hesse is requesting \$10,000 for a rural water hookup to his residence in rural Kindred located in Cass County. The total estimated project cost is \$24,104. A copy of the grant application is attached to these minutes as Annex IV.

### East Central Regional Water District

Jerod Klabo is requesting \$10,000 to provide water to his home in rural Hatton, which is located in Steele County. The total estimated project cost is \$25,800. A copy of the grant application is attached to these minutes as Annex V.

Ben Sobolik is requesting \$9,500 to install a rural water line to his residence near Thompson, which is located in Grand Forks County. The total estimated project cost is \$21,500. A copy of the grant application is attached to these minutes as Annex VI.

### McKenzie County Water Resource District

Brinda Kleppen is requesting \$11,710 for a rural water hook up to her residence in Watford City located in McKenzie County. The total estimated project cost is \$25,920. The project is eligible for \$10,000 in grant funding. A copy of the grant application is attached to these minutes as Annex VII.

Michael and Tammy Paul are requesting \$3,725 to install a rural water line to their home in Watford City located in McKenzie County. The total project cost is \$9,950. A copy of the grant application is attached to these minutes as Annex VIII.

### McLean-Sheridan Rural Water

Buck Robinson is requesting \$1,973 for a rural water line to his new home in Coleharbor located in McLean County. The total estimated project cost is \$6,446; however, the meter pit at a cost of \$522 is an ineligible expense item, reducing the amount eligible for funding to \$1,712. A copy of the grant application is attached to these minutes as Annex IX.

Donald Robinson is requesting \$1,973 for a rural water line to his new home in Coleharbor located in McLean County. The total estimated project cost is \$6,446; however, the meter pit at a cost of \$522 is an ineligible expense item, reducing the amount eligible for funding to \$1,712. A copy of the grant application is attached to these minutes as Annex X.

### Stutsman Rural Water District

Jayden Hesch is requesting \$8,000 for a rural water hookup to his residence near Woodworth located in Stutsman County. The total estimated project cost is \$18,500. A copy of the grant application is attached to these minutes as Annex XI.

Ryan Skjeret is requesting \$7,350 to install a rural water line at his residence in Jamestown located in Stutsman County. The total estimated project cost is \$17,200. A copy of the grant application is attached to these minutes as Annex XII.

### Additional Rural Water Applications

Ms. Mooridian reported two other applications were received after the August 1 deadline. She asked the committee if they would like to consider these today or wait until the next round of applications are received in the spring of 2025.

Motion by Director Metzger to consider the late grant applications received for Jake Beckel and Kenneth Mees for funding today. Upon roll call vote, the following directors voted aye: Blanchfield, Boote, Kaiser, Metzger, Rogers and Walter. Motion carried.

### East Central Regional Water District

Jake Beckel is requesting \$10,000 to connect rural water to his home near Thompson located in Grand Forks County. The total estimated project cost is \$28,067. A copy of the grant application is attached to these minutes as Annex XIII.

### McKenzie County Water Resource District

Kenneth Mees is requesting \$1,156 to install a rural water line to his home in Watford City located in McKenzie County. The total project cost is \$4,811. A copy of the grant application is attached to these minutes as Annex XIV.

Motion by Director Blanchfield to approve funding in the amount of \$73,155 for allocation to the following rural water projects:

Up to 50 percent of the local, non-federal share of the eligible costs not to exceed \$10,000 to Cass Rural Water District for rural water installation for Jason Hesse located in Cass County.

Up to 50 percent of the local, non-federal share of the eligible costs not to exceed \$10,000 to East Central Regional Water District for rural water installation for Jerod Klabo located in Steele County.

Up to 50 percent of the local, non-federal share of the eligible costs not to exceed \$9,500 to East Central Regional Water District for rural water installation for Ben Sobolik located in Grand Forks County.

Up to 50 percent of the local, non-federal share of the eligible costs not to exceed \$10,000 to McKenzie County Water District for rural water installation to the Brinda Kleppen residence located in McKenzie County.

Up to 50 percent of the local, non-federal share of the eligible costs not to exceed \$3,725 to McKenzie County Water District for rural water installation to the Michael and Tammy Paul residence located in McKenzie County.

Up to 50 percent of the local, non-federal share of the eligible costs not to exceed \$1,712 to McLean-Sheridan Rural Water for rural water installation to the Buck Robinson residence located in McLean County.

Up to 50 percent of the local, non-federal share of the eligible costs not to exceed \$1,712 to McLean-Sheridan Rural Water for rural water installation to the Donald Robinson residence located in McLean County.

Up to 50 percent of the local, non-federal share of the eligible costs not to exceed \$8,000 to Stutsman Rural Water District for rural water installation to the Jayden Hesch residence located in Stutsman County.

Up to 50 percent of the local, non-federal share of the eligible costs not to exceed \$7,350 to Stutsman Rural Water District for rural water installation to the Ryan Skjeret residence located in Stutsman County.

Up to 50 percent of the local, non-federal share of the eligible costs not to exceed \$10,000 to East Central Regional Water District for rural water installation to the Jake Beckel residence located in Nelson County.

Up to 50 percent of the local, non-federal share of the eligible costs not to exceed \$1,156 to McKenzie County Water District for rural water installation to the Kenneth Mees residence located in McKenzie County.

Second by Director Walter. Upon roll call vote, the following directors voted aye: Blanchfield, Boote, Kaiser, Metzger, Rogers and Walter. Motion carried.

### **Municipal Request**

### City of McVille

The City of McVille had requested \$2,500 during the previous round of applications for the WSAGP. The request, reviewed at the May 2024 MR&I Committee meeting, was to replace a water service line, curb stop and riser that was discovered to be a galvanized/lead line when digging to repair a located water leak. The total estimated project cost at that time was \$5,000.

During the May meeting, there were questions as to whether this was the main service line or the line from the main service line to the house.

The committee deferred funding for the City of McVille pending additional information regarding this project.

A reply was received from the City of McVille indicating the city is responsible for the shut off valve. The items and labor involved total \$2,160. The revised funding request would be \$1,080. A copy of the grant application is attached to these minutes as Annex XV.

Chairperson Kaiser said this was unexpected on the city's part finding the galvanized pipe. Once that is discovered, it must be changed out. It is a health and safety issue and does meet some of the criteria.

Motion by Director Walter to approve up to 50 percent of the local, non-federal share of the eligible costs not to exceed \$1,080 to the City of McVille to replace the galvanized pipe located within McVille. Second by Director Boote. Upon roll call vote, the following directors voted aye: Blanchfield, Boote, Kaiser, Metzger, Rogers and Walter. Motion carried.

### FEDERAL MR&I PROGRAM

**Fiscal Year 2024 Funding Recommendation - -** Ms. Mooridian referred to the letter Garrison Diversion received from the Department of Water Resources confirming the remaining federal MR&I funding is \$12,227,000 and will be provided through the Fiscal Year (FY) 2024 funding. A copy of the letter is attached to these minutes as Annex XVI.

Ms. Mooridian stated this is to allocate \$10.7 million of FY2024 funding. The Northwest Area Water Supply Project (NAWS) will receive \$7.7 million and \$3 will go to the Eastern North Dakota Alternate Water Supply Project (ENDAWS). There is also funding held out for program administration. By approving this funding, it will close out the MR&I Program funding appropriated in the Dakota Water Resources Act of 2000. This was approved by the State Water Commission at its August 8 meeting.

Motion by Director Rogers to recommend the allocation of FY2024 federal MR&I funding of \$10,700,000 with \$7,700,000 going to the NAWS Project and \$3,000,000 to the ENDAWS Project, as well as the allocation of FY2023 funding of \$169,722 to go toward MR&I program administration to the Executive Committee. Motion is contingent upon available funding; project must follow Federal MR&I Program requirements and delegates the Secretary the ability to move funds between project elements in order to facilitate efficient project completion. Second by Director Metzger. Upon roll call vote, the following directors voted aye: Blanchfield, Boote, Kaiser, Metzger, Rogers and Walter. Motion carried.

**MR&I Construction Reports - -** Ms. Mooridian referred to the MR&I construction report dated July 31. Total 2024 MR&I expenditures are \$4,260,389. Remaining federal MR&I funds are \$8,572,534. The 2024 Bipartisan Infrastructure LAW (BIL) funding expenditures are \$1,783,3367, which was for the NAWS Project. Remaining funds are \$38,761,632. Copies of these reports are attached to these minutes as Annex XVII.

**Increased Authorization Request - -** Ms. Mooridian updated the committee on Senator Hoeven's draft bill that would modify the authorization of appropriations for state and tribal MR&I water service. There is a pending hearing date of September 11.

There being no further business to come before the committee, the meeting adjourned at 1:56 p.m.

The United States Bureau of Reclamation (USBOR) has confirmed the remaining federal Municipal, Rural, and Industrial (MR&I) water supply program funding to reach the program ceiling is \$12,227,000. This amount is being provided through fiscal year (FY) 2024 funding. Project funds for North Dakota total \$10,700,000, with \$7,700,000 toward the Northwest Area Water Supply (NAWS) project (\$5,700,000 in Appropriation funding to Cooperative Agreement R17AC00049 and \$2,000,000 in BIL funding to Cooperative Agreement R17AC00049 and \$2,000,000 in BIL funding to Cooperative Agreement R23AC00093) and \$3,000,000 at 75 percent cost-share for continuing design on the Eastern North Dakota Alternate Water Supply Project (ENDAWS, Cooperative Agreement R17AC00049). Remaining FY 2024 funds have been designated by the USBOR for the North Dakota Natural Resources Trust in the amount of \$600,000 and for USBOR project administration in the amount of \$1,200,000. Also note, this request includes allocation of \$169,722 of additional FY 2023 funding for MR&I program administration.

Because the FY 2024 funding meets the total program ceiling, no further funding will be available without additional federal appropriation through new legislation. North Dakota's Congressional delegation continues to work with the state and tribal nations to move new legislation forward.

The NAWS Biota Water Treatment Facility was determined to be a 100 percent federal funding responsibility. FY 2024 funds should be sufficient to cover the remaining federal balance for the NAWS Biota Water Treatment Facility Phase I construction contracts.

This request was approved by the State Water Commission at their August 8, 2024 meeting. A State Municipal, Rural, and Industrial Water Supply Program Federal Funding Summary is attached.

I recommend the Garrison Diversion Conservancy District approve the allocation of FY 2024 federal MR&I funding of \$10,700,000, with \$7,700,000 toward the NAWS project and \$3,000,000 toward the ENDAWS project. Also, I recommend allocation of FY 2023 funding of \$169,722 toward MR&I program administration. This approval is contingent on available funding, that the projects follow Federal MR&I Program requirements, and delegates to the Secretary the ability to move funds between project elements in order to facilitate efficient project completion.
