MR&I COMMITTEE

Garrison Diversion Conservancy District Carrington, ND May 19, 2025

A meeting of the Garrison Diversion Conservancy District MR&I Committee was held May 19, 2025, at the district headquarters. The meeting was called to order by Chairman Kassian at 9:00 a.m.

The meeting was recorded to assist with compilation of the minutes.

A copy of the registration sheet is attached to these minutes as Annex I.

READING OF THE MINUTES

Motion by Director Metzger to dispense with the reading of the September 16, 2024, MR&I Committee minutes and approve them as distributed. Second by Director Kaiser. Upon voice vote, motion carried.

RETURN OF GRANT FUNDS

Cass Rural Water Users District

Alex Pfeifer was awarded funding from the Water Supply Assistance Grant Program (WSAGP) in May 2023 through the Cass Rural Water Users District (CRWUD) in the amount of \$10,000. The two-year project deadline has been reached, and these funds have not been expended. CRWUD's manager has been contacted with no reply received.

Greater Ramsey Water District

Greater Ramsey Water District (GRWD) also received WSAGP funds in May 2023 for the three grant applicants: 1) Brent Newgard up to \$10,000, 2) Dale Snyder up to \$7,150 and 3) Ryan Topp up to \$10,000. The two-year project deadline has been reached, and these funds

have not been expended. GRWD's manager contacted Garrison Diversion stating these applicants are now part of an expansion project and the grant funding can be returned to the WSAGP.

CURRENT FUNDING TABLE & PROJECT REVIEW

Merri Mooridian, Secretary, referred to the WSAGP outstanding projects table, reporting the program expenditures so far in 2025 are \$23,550. There is \$141,119 outstanding. A copy of the table is attached to these minutes as Annex II.

COMPLETED PROJECTS

Ms. Mooridian referred to the WSAGP completed projects table through 2024, stating the total amount of approved projects is \$718,612 with an expended amount of \$559,289. Projects that did not come to fruition total \$159,323, which goes back into the WSAGP reserve account. A copy of the table is attached to these minutes as Annex III.

Chairman Kassian stated the number of grant applications is steadily increasing. At this time, there is \$475,000 in the MR&I Reserve Account. Today's grant requests come to about \$300,000. There are funds available plus the additional \$37,000 in unused funds being returned today.

Ms. Mooridian added the reserve account does not include the \$300,000 available for the grant program in 2025.

AGENDA CHANGE

Chairman Kassian informed the committee another grant application was received last week from Greater Ramsey Water District. He feels it should be added to the list of applicants being considered today and suggested the committee approve adding it to the agenda.

Motion by Director Rogers to add Greater Ramsey Water District's grant application for Treston Lura to the agenda. Second by Director Kaiser. Upon voice vote, motion carried.

Ms. Mooridian commented \$300,000 per year is made available for the grant program. Typically, a portion of that is reserved for municipalities. There is also approximately \$500,000 in the MR&I reserve account.

Chairman Kassian said based on recent experience, a large amount of rural water applications is being received with very few municipal grant requests submitted. The 50/50 split may be something the committee needs to look at in the future. He is not sure that rule should apply any longer.

Ms. Mooridian said the original guidelines did allow for a 50/50 split of the annual \$300,000 between the rural and municipal applicants; however, the rural side can borrow from the municipal funding if needed. She will check into the intent of the original program guidelines and report back at the next meeting.
